We recognise their continuing connection to land, waters and culture and pay our respects to their Elders past, present and emerging.


We support initiatives that encourage greater unity, knowledge, cultural awareness and respect for the first occupants of our land.

It is a reminder of the importance of cooperation between people if all are to prosper.

# Chair's Message

#### Foreward

The Barwon South West is well known for successful economic transition and has undertaken significant planning to support further economic diversification and growth, benefiting residents across the entire region.

Impacts of the COVID-19 pandemic have driven a different approach to the 2021-22 RDA BSW Business Plan. Over the past 12 months, immediate barriers to economic recovery have emerged that threaten to impact the region's short and mid-term economic goals. In addition to addressing these recovery barriers, we must also work together to seize emerging opportunities while continuing to support regional stakeholder group initiatives that address our longer-term strategic focus areas.

Priority sectors that have been most negatively impacted by the pandemic include the visitor economy, international education, food processing, and meat and seafood exports. Recommendations to support these sectors through the crisis phase are included in this plan, along with mid-term recommendations to ensure a more resilient economy into the future.

Whilst the negative impacts of the COVID-19 pandemic are severe, restarting our economy also presents a unique opportunity for business transformation and growth, allowing us to proactively redesign our economic foundations to achieve a more resilient and prosperous regional economy for the Barwon South West region.











#### Chair's Message (continued)

#### 2020-21 Achievements

In this challenging pandemic environment, the RDA BSW Committee has provided critical advice to both state and federal governments on the impacts of COVID-19 through participation in regular teleconferences and written submissions on urgent and targeted interventions to support businesses and the visitor economy in our region. We also provided advice on opportunities for growth. Outcome highlights include:

- funding to establish Hycel Technology Hub, the nation's first regional hydrogen hub at Deakin University in Warrnambool
- retention of the Australian Tax Office and associated jobs in Geelong
- temporary COVID disaster payments to support business and worker through ongoing lockdowns

The Geelong City Deal has completed works on three Revitalising Central Geelong projects as it continues to roll out the 10-year program of works.

RDA BSW continued to focus on job creation and enabling and delivering private sector investment through the work of Regional Development Victoria's Investment and Trade team, including establishing the \$23.4 million Private Sector Business Enablement Fund for the Shipwreck Coast region.

We worked with local government and industry to deliver regional projects including:

- Creative Industries Strategy for G21 region
- Great South Coast Economic Futures Implementation Planning
- Geelong City Deal Brand Concept Development
- Brand Geelong Stage 2









#### Chair's Message (continued)

#### **Activities and Interventions**

The immediate barriers to economic recovery that threaten to impact the region's short and mid-term goals include:

- Skilled workforce shortages
- Affordable and accessible housing
- Visitor economy decline
- Digital infrastructure and capability

Key emerging opportunities include:

- Competitive advantage in emerging Hydrogen Economy
- Greater support for regions at state and federal levels
- Increase in migration to regional areas
- Greater opportunity to influence policy
- Opportunity to 'build back better' in a more equitable, environmentally sustainable and socially responsible way.

The RDA BSW Committee must operate for maximum impact over the next 12-18 months. We have identified 'interventions' to accelerate collaborative short-term and mid-term outcomes for our region, including clarifying the roles and relationships of our regional stakeholder groups, improving the consistency of our evidence base and strengthening coordination of advocacy efforts from the region.


We look forward to supporting the priorities of our regional stakeholders and will work with them to deliver even stronger outcomes for the region on behalf of the Australian Government.

# **RDAs & Regional Partnership Integration**



The Australian and Victorian Governments are committed to strengthening the regions and building stronger communities through the RDA network. RDA Committees play an important role in their regions by focusing on economic development, facilitating local projects that aim to make a difference for their local communities and promoting government programs.

As part of efforts to support stronger integration between the work and priorities of RDA committees, Regional Partnerships (RPs) and Regional Development Victoria (RDV), up to three RDA Committee members will sit on each RP to ensure there is Commonwealth representation and provide input and advice on priorities requiring Commonwealth investment.

RDA RP members will continue to deliver the requirements of the RDA Charter and support regional economic development planning. RDA RP members will engage, through the RPs, on broader regional issues (economic, social and environmental) and collaborate to leverage public and private investment in the region. This will strengthen RDAs capacity to provide comprehensive advice on socio-economic issues and economic development opportunities for the Victorian and Commonwealth Government to drive economic growth and investment and guide government grant programs and investment decisions by:

- Capitalising on the Regional Partnership model and extend the benefits to the Commonwealth Government
- Delivering a direct entry point for country communities to communicate their priorities, articulate challenges and seek solutions from both State and Commonwealth governments
- Reduce duplication and confusion, so the community can have their issues easily addressed by the appropriate entity
- Improve identification of government and industry investment opportunities
- The response to region-specific priorities will be greatly improved through the connection of Commonwealth and Victorian programs and strategies.



#### STAKEHOLDER INTERVIEW OUTCOMES

We consulted with key stakeholder groups (see page 6) to inform our discussion on how the RDA BSW Committee might improve its Charter outcomes. We found:

- Inconsistent understanding of the relevance and value of the RDA Charter objectives
- Several of our key regional stakeholder groups have recently renewed their leadership and/or membership
- Key regional stakeholder groups are currently reviewing their priorities and activities
- Our previous Business Plan's strategic focus is supported by our regional stakeholder groups
- Immediate barriers to economic recovery have been identified by key regional stakeholder groups

Informed by consultation with key regional stakeholder groups, we reviewed the relevance and prioritisation of the five strategic focus areas of our business plan.



# **RDA BSW Planning Day**

#### **Reviewing our Strategic Focus Areas**

In the wake of COVID-19, we determined that the RDA BSW Business Plan needed not only to address mid-term priorities for economic growth, but also to achieve maximum impact for economic recovery over the next 12-18 months, in the lead-up to State and Federal elections. At our planning day we considered:

- Impacts of COVID-19 for the region
- Immediate economic barriers and opportunities
- Exemplar methodology for RDA BSW Committee activities
- How we might better clarify roles, responsibilities and relationships between regional stakeholder groups.

#### Regional stakeholder group input

To inform our discussion on how the RDA BSW Committee might improve its RDA Charter outcomes, we asked key regional stakeholder groups to provide their opinion on the RDA BSW Committee Strategic Focus Areas, our short and mid-term priorities and the role of the RDA BSW Committee.

#### Immediate issues

Regional stakeholder groups supported addressing immediate barriers to economic recovery. They viewed a shared regional evidence base and coordination of advocacy effort as high value activities, along with leveraging competitive advantage for growth and supporting mid-term strategic focus areas.

#### **Interventions and actions**

This plan presents interventions to address immediate barriers and actions to support initiatives of our regional stakeholder groups in addressing our mid-term strategic focus areas.



The team has extensive networks and experience supporting economic outcomes.

#### **Executive support**

The Director of Regional Development provides strategic and operational leadership to the RDA BSW Committee and the executive support team. The executive support team promotes the region's activities to all levels of government, industry, business and community, highlighting competitive advantages and encouraging decentralisation and relocation opportunities. They oversee RDA projects and report on activities, including the management and monitoring of the Commonwealth and State grants programs.

Regional Development Victoria's Investment and Trade team lead private investment facilitation activities on behalf of RDA BSW. This work directly contributes to outcomes that support economic growth, investment and job creation.

RDA BSW executive support has offices at each end of the region in Geelong and Warrnambool and will soon establish an office in Portland.

#### Top 5 Strategic Focus Areas

- **1. Build 21st Century Digital Capability** for our region to remain economically competitive and recover from the impacts of COVID-19, investment in digital infrastructure is required urgently. Reliable connectivity will activate business transformation and growth by driving investment in digital platforms, technology and digital skills development.
- 2. Revive and Reimagine Our Visitor Economy leverage our region's world-renowned natural assets and the \$370 million public investment in the Geelong City Deal to drive private sector investment in high-value tourism and Indigenous cultural tourism product development opportunities.
- **3. Diversify and Strengthen our Economic Foundations** pathway prospective new high value opportunities, taking advantage of the region's comparative advantages and latent potential.
- **4. Create Skills and Education Fit for the 21st Century** urgent support needed to activate the economic contribution of the education sector in our region (deeply impacted by COVID-19), as well as medium and longer term need to ensure a strong and well aligned pipeline of people with the skills and capabilities required to meet industry demand now and in future.
- **5. Switch on Clean Energy and Green Collar Jobs** harness compelling regional advantages including the skilled manufacturing workforce to create a path to a greener energy grid, new fixed and distributed power applications and a potential new export sector and facilitate establishment of circular economy waste as a resource project.

#### **Top Business Activities**

- **1. Deliver the RDA Brown Bag Briefing Series** a series of out-of-session briefings with key stakeholders to share information and collaborate where appropriate on immediate barriers and opportunities in the Barwon South West region.
- 2. Hold the inaugural RDA BSW Regional Stakeholder Forum to promote coordinated advocacy effort and regional prioritization.
- **3. Lead engagement activities** that will contribute to the development of the Victorian Government's Regional Economic Development Strategies (REDS) in our region to ensure alignment with RDA BSW strategic focus areas and ensure the plans address the Commonwealth regional priorities.
- **4. Invest in regional initiatives** that will enable high value growth and diversification opportunities that will support our region's recovery and transformation and address barriers to economic recovery Delivering Key Worker Housing in the Barwon South West, Understanding the Spirit Traveller to unlock the opportunity for Regional Victoria and other projects that support our strategic focus or intervention areas.
- 5. Work with all levels of government to deliver targeted interventions that support outcomes in our mid-term intervention focus areas.
- **6. Provide regional recovery advice to government** on actions and interventions required to support the needs of sectors hardest hit by COVID-19 the tourism, events, hospitality, arts, entertainment, retail and university sectors and ensure there are localised pathways that support targeted economic recovery for these sectors.

## **RDA Charter**

The RDA Charter outlines the role and expectations of the Australian Government to the future activities of the RDA Committees. The Charter has four elements and collaborating with other RDA Committees, all levels of government, and the private sector, RDA Committees will:

- a. Facilitate regional economic development outcomes, investment, local procurement and jobs.
- b. Promote greater regional awareness of and engagement with Australian Government policies, grant programs and research.
- c. Improve Commonwealth regional policy making by providing intelligence and evidence-based advice to the Australian Government on regional development issues.
- d. Co-ordinate the development of a strategic regional plan, or work with suitable existing regional plans that will align with the Commonwealth's regional priorities.

#### **Strategic Focus Areas and Interventions**

In addition to our five strategic focus areas RDA BSW has identified five interventions to address immediate barriers to economic recovery and seize economic growth opportunities.

These interventions will guide the Committee's efforts over the next 12 – 18 months:

- Affordable housing for key workers
- Direct support for Visitor Economy
- Address skill and workforce shortages
- Digital access and capability gaps
- Hydrogen Economy competitive advantage activities.





"The Budj Bim Cultural Landscape, located in the traditional Country of the

"The Budj Bim Cultural Landscape, located in the traditional Country of the Gunditjmara people in south-eastern Australia, consists of three serial components containing one of the world's most extensive and oldest aquaculture systems. The Budj Bim lava flows provide the basis for the complex system of channels, weirs and dams developed by the Gunditjmara in order to trap, store and harvest kooyang (short-finned eel – Anguilla australis). The highly productive aquaculture system provided an economic and social base for Gunditjmara society for six millennia. The Budj Bim Cultural Landscape is the result of a creational process narrated by the Gunditjmara as a deep time story, referring to the idea that they have always lived there. From an archaeological perspective, deep time represents a period of at least 32,000 years. The ongoing dynamic relationship of Gunditjmara and their land is nowadays carried by knowledge systems retained through oral transmission and continuity of cultural practice."

Strategic Plan Alignment

The BSW region boasts several mature and accomplished regional alliances, partnerships and networks. These organisations undertake extensive community consultation to inform the region's well-developed regional strategic plans, growth plans and agreed regional priorities.

In recognition of the complimentary roles and differentiated responsibilities across these organisations, RDA BSW endeavours not to duplicate but to align, add value and identify opportunities to achieve common objectives.

Our work aligns with key regional stakeholder group strategic plans, including the G21 Geelong Region Plan, Great South Coast Region Growth Plan, Geelong Economic Futures, Great South Coast Economic Futures, Our Country Our Plan, Visitor Economy Master Plan for the Great Ocean Road Region (draft), and the Great Ocean Road Action Plan.

#### **Regional Economic Development Strategies**

RDA BSW will work with the Victorian Government to develop Regional Economic Development Strategies (REDS) for each of our Regional Partnership regions to ensure the plans address the Commonwealth regional priorities.

The REDS will provide a consistent evidence base and the strategic framing of economic opportunities to coordinate investment and activity in each region. The REDS methodology, approach and timing is consistent with the requirements and best practice parameters for the Strategic Regional Plan requirements in that they will:

- be living documents, with a long-term timeframe
- be underpinned by extensive engagement with targeted stakeholders
- describe strategic directions based on areas of comparative advantage
- identify opportunities
- take into consideration the strategic policy environment at a national, state and local level.

Pictured above is the frame of the Eel Aquaculture Centre, with Eel holding tank already in place. Once complete the Centre will be an interactive space where visitors can view and learn about the life cycle of eels and their important place in the culture of the Gunditjmara people, as well as enjoy food and drink at the on-site café. The Centre is located at Lake Condah (Tae Rak), where eels were farmed for food and trade over thousands of years and evidence of sophisticated engineered traps and channels along the lava flow still remains.



# Context BARWON SOUTH WEST REGION

The Barwon South West regional context is unique in Victoria and, indeed, Australia. Within the region is **Victoria's second biggest city, Geelong**, which has a strong sense of identity and is experiencing population growth more than most other regional cities in Australia.

The region comprises two sub-regions, Barwon and the Great South Coast (GSC). The Barwon sub-region encompasses the local government areas of **Greater Geelong**, **Queenscliffe**, **Colac Otway** and **Surf Coast**. The GSC encompasses the local government areas of **Warrnambool City**, **Moyne**, **Corangamite**, **Glenelg** and **Southern Grampians**.

The residential population of the BSW region was **403,569 people in 2017**. The region abuts the nation's largest population growth corridor (west of Melbourne), and it is expected the region will reach a population of more than **480,000 by 2022**.

The BSW has three economies: one inland which is founded on agriculture; one on the coast that is dominated by tourism and amenity lifestyles; and one in Geelong which has a diverse economic and social base.

The main industries are manufacturing, retail trade, health care, construction, education and training, agriculture, forestry, fishing and tourism. Manufacturing, health and retail trade are currently the largest employing industries, although the economy has significant opportunities for growth in new energy, advanced manufacturing and food security industries.

Environmentally, the BSW enjoys higher than average rainfall and wind, providing us with ongoing competitive strengths in agriculture, food, renewable and clean energy production. The region also boasts nearly **forty percent of Victoria's coastline**, including marine national parks, the **Surf Coast**, the **Shipwreck Coast** and the iconic **Great Ocean Road**.

Beyond the coast are diverse and vulnerable landscapes including the **UNESCO World Heritage listed Budj Bim**, areas of State Forest and National Park, internationally significant wetlands, the **Grampians** and **Otway Ranges** and highly productive timber and agricultural land.

The region has a wide selection of **tertiary education providers** including a multi-campus university, two TAFE colleges and various private providers operating throughout the region. It also boasts a significant transport network, with infrastructure that includes the **Port of Geelong** and **Port of Portland**, **Avalon Airport**, Princes Highway Transport Corridor, passenger and freight rail infrastructure.

Appendix 1 – RDA BSW Economic Recovery Submission to Commonwealth Support business adaptation and economic transformation (Page 3-4)

**Priority Objective:** 

Provide economic stimulus programs facilitating business adaptation and industry transformation to areas that are growing and are sustainable.

**Top Priorities:** 

- A. Fast track funding and implementation of major projects in the region already approved and committed to in the Geelong City Deal, prioritising the construction of:
  - i. the Geelong Convention Centre, and
  - ii. the Twelve Apostles Precinct.
- B. Pilot Avalon Airport as a low risk 'travel bubble' for people to move between states, territories and other nations leveraging its geographic location, existing infrastructure, and existing quarantine facilities to limit risk.
- C. Fast track investment and implementation in a Portland Economic Diversification stimulus package.
- D. Fast track investment to address priority digital infrastructure supply shortfalls, including mobile coverage, and access to business-grade broadband to support improved digital connectivity in line with recommendations in the region's Digital Plans.

#### **Recommendations:**

Short Term (Crisis Management)

- Accelerate planning approvals for major public and private sector projects in the region, with approval specifically conditional on actions creating stimulus – such as bringing forward construction start dates, mandating local content and employment requirements (as has been done for the Geelong City Deal), and quotas for new apprentices and trainees.
- 2. Accelerate the implementation of small to medium sized Local Government Community and Economic Infrastructure Projects mandating content and employment provision targeting regional businesses and local job seekers.

- 3. Resource Regional Tourism Boards to facilitate industry development programs enabling business rebuilding and transition initiatives to support adaption of tourism businesses, and implement new tactical marketing campaigns timed to align with approved easing of travel restrictions.
- 4. Resource our region's established innovation precincts to provide impacted businesses with specific opportunities to participate in business model adaptation and redesign programs -enabling transition of output and employment from areas at risk into those that are growing and sustainable.
- 5. Mandate local content provisions for publicly funded stimulus projects ensuring revenue and employment outcomes are retained within the region to multiply local economic recovery objectives.
- 6. Enhance business confidence by reducing the financial risk of making new business investments, by providing additional immediate tax incentives such as instant asset write-offs and deduction, targeted stimulus payments and payroll tax reductions.

Medium Term (Stabilisation and Recovery)

- 7. Fast track approval, funding and implementation to support investment in major projects that support high value economic diversification in the region, with a focus on:
  - High-value agriculture delivering sustainable high value food precincts critical to the nation's food security;
  - ii. Renewable energy as a priority industry sector and vital part of the future energy mix integral to supporting economic growth and diversification in the region; and
  - iii. Tourism implementation of the BSW Visitor Economy Investment Pipeline, including Traditional Owner opportunities.
- 8. Fast track policy and provide a supportive regulatory framework to progress \$3-5 billion worth of investment ready renewable energy projects located in the BSW region.
- 9. Accelerate implementation of the Great Ocean Road Action Plan and establishment of the Great Ocean Road and Parks Authority (GORAPA), enabling coordinated land management to support sustainable tourism in the Great Ocean Road region.
- 10. Use the bilateral 10-year Geelong City Deal Agreement as a framework for increased investment into current and emerging economic stimulus projects.

Appendix 2 – RDA BSW Economic Recovery Submission to Commonwealth Transformation of our labour market (Page 3-4)

#### **Priority Objective:**

Facilitate development of shorter labour market supply chains, using local education and training capabilities to close key skills gaps and meet demand from new and emerging growth sectors.

#### **Top Priorities:**

- E. Fast track the additional \$18 million Federal and State Government investment required for the next phase of the Hycel Technology Hub, positioning the region as a national leader in hydrogen energy knowledge and skills testing and demonstrating new technologies, and leveraging new growth opportunities in the emerging world-wide market for clean hydrogen energy.
- F. Provide resources to extend reach and amplify the impact of local and regional job boards, matching local employment opportunities (demand) with local job seekers (supply), for example the Geelong Careers initiative.
- G. Implement a National Employment Scheme to create employment opportunities for job seekers in: surge industries such as health and cleaning; local and community initiatives and projects; and state and national infrastructure projects.
- H. Mandate and provide support for a quota of apprenticeships and traineeships for publicly funded stimulus projects targeting key skills gap areas and delivering new employment opportunities for young people.

#### Recommendations:

**Short Term (Crisis Management)** 

11. Develop a national response to address the disruption to regional and rural high school students to ensure they remain engaged and active in their studies, and have clear pathways to further education and employment.

- 12. Improve digital infrastructure and capability building in education/training facilities to support students.
- 13. Provide financial support in the form of wage subsidies or tax incentives to limit disruption to practical placements required for completion of TAFE and tertiary qualifications.
- 14. Facilitate domestic and international labour mobility pathways enabling employers to directly recruit high-skilled people to address key skills gaps and hard to fill job roles that are crucial for business continuity, growth, and essential services.
- 15. Provide job seekers and businesses impacted by COVID-19 with specific opportunities to accelerate the development of digital skills focused on business model innovation and customer acquisition using our region's established innovation precincts and programs.

Medium Term (Stabilisation and Recovery)

- 16. Fast track the funding for the key findings and recommendations of the National Regional, Rural and Remote Tertiary Education Strategy, with specific focus on:
  - i. improving access to tertiary study options for regional students including access to reliable and fast internet services;
  - ii. more flexible financial support arrangements for regional students;
  - iii. a regionally-based model for professional career advice; and
  - iv. increasing research capacity of regional universities.
- 17. Invest in building a stronger regional learning system focused on skills development, by improving links and collaboration between employers (demand), training providers, and job seekers (supply) to support the priority growth areas of high value agriculture, advanced manufacturing and renewable energy.



Appendix 3 – RDA BSW Economic Recovery Submission to Commonwealth Create shorter, diversified and more durable industry supply chains (Page 3-4)

#### **Priority Objective:**

Facilitate development of shorter, diversified and more durable industry supply chains, prioritising input quality and consistency of supply ahead of lowest cost.

#### **Top Priorities:**

- Collaborate with the university sector to provide additional financial and social support to displaced international students; as well as communication and marketing activities to rapidly rebuild the reputation of Australia as a safe, caring and desirable destination for the multi-billion dollar international student market.
- J. Use existing infrastructure at Avalon Airport as a priority entry and exit point for state and international airfreight, leveraging its geographic location, spacious site, and existing quarantine facilities to limit risk.
- K. Fast track investment from the Victorian Higher Education Investment Fund to establish a National Centre of Composite Materials at Deakin University's Geelong Future Economy Precinct, to support industrial scale capabilities across the full composite value chain, leveraging the increasing opportunity in this fast-growing sector and utilising the existing capability of the region's advanced manufacturing industry.

#### **Recommendations:**

#### Short Term

- 18. Provide funding to facilitate adaptation and uptake of local supply chain opportunities to support immediate industry supply shortfalls.
- 19. Prioritise immediate local supply opportunities for publicly funded stimulus projects for example manufacturing composite sleepers for rail projects and upgrades, and supply of locally manufactured modular kits for social housing projects.

Medium Term (Stabilisation and Recovery)

- 20. Facilitate the development of advanced circular economy supply chain technologies that can be commercialised to open up new markets, jobs and growth by leveraging the region's capabilities and emerging expertise at Deakin University.
- 21. Initiate an import replacement program to identify and activate opportunities for investment in the development of local supply chain opportunities leveraging industry capability, improved business continuity, and greater sovereignty in the event global supply chains are disrupted.



#### Appendix 4

#### **Economic Impacts of COVID-19 (Page 3)**

- 1. From the start of the pandemic job losses peaked in April, prior to firms gaining access to JobKeeper in May. At its peak there were 9.1% fewer payroll jobs in the Geelong SA4 Region (Greater Geelong, Queenscliffe and Surf Coast) and 9.3% fewer in Warrnambool and South West (Colac-Otway, Corangamite, Moyne, Warrnambool, Southern Grampians, Glenelg). (Source: ABS Wages and Payroll, Week Ending 5 June 2021, 2021)
- 2. In August 2020 at the peak of the second lockdown when the 'ring of steel' separated regional Victoria from metropolitan Melbourne, at least 19.8% of businesses in each of the region's municipalities were accessing JobKeeper to support staff, up to 54.1% in the case of Surf Coast Shire. (REMPLAN JobKeeper Explorer, 2021)
- 3. From the start of the pandemic job losses peaked in April, prior to firms gaining access to JobKeeper in May. At its peak there were 9.1% fewer payroll jobs in the Geelong SA4 Region (Greater Geelong, Queenscliffe and Surf Coast) and 9.3% fewer in Warrnambool and South West (Colac-Otway, Corangamite, Moyne, Warrnambool, Southern Grampians, Glenelg). (Source: ABS Wages and Payroll, Week Ending 5 June 2021, 2021)
- 4. All municipalities across Barwon and Great South Coast have experienced increases in the proportion of the population on JobSeeker since the start of COVID-19. Currently (December quarter 2020). Glenelg LGA has 12.6 per cent of all those aged between the highest across GSC and Barwon (REMPLAN JobSeeker Explorer, 2021)
- 5. In calendar year 2020, there were an estimated 5,270,000 visitor trips to the Barwon region, 49.5% less / 5,170,000 fewer than in 2019. All types of visitation have declined, particularly international overnight and interstate overnight stays. In calendar year 2020, visitors stayed an estimated 6,240,000 nights in the region, 39.4% less / 4,060,000 fewer than in 2019.
- 6. In calendar year 2020, visitors spent an estimated \$1.1 billion in the region, 45.3% / \$900 million less than in 2019.
- 7. In calendar year 2020, there were an estimated 1,960,000 visitor trips to the GSC region, 36.0% less / 1,100,000 fewer than in 2019. All types of visitation have declined, particularly international overnight and interstate overnight stays. In calendar year 2020, visitors stayed an estimated 3,120,000 nights in the region, 21.5% less / 850,000 fewer than in 2019.
- 8. In calendar year 2020, visitors spent an estimated \$620 million in the region, 11.8% / \$80 million less than in 2019. Interestingly, spend from intrastate overnight stays has actually increased by 14.0%.

In the year leading up to the pandemic (March 2019 – March 2020), 65.3% of visitors to Barwon and 54.2% of visitors to the Great South Coast were domestic daytrippers. If these daytrippers became an overnight visitors, annual tourist expenditure would increase.

- 9. Housing availability Apollo Bay's Chamber of Commerce conducted a survey and found there were 85 permanent positions and 113 seasonal positions not being filled <u>because of a shortage of affordable</u> <u>housing</u>, causing some businesses to reduce hours of opening by 50 per cent just so their staff can have a day off. They say it's created an \$11 million loss for the economy.
- 10. Regional Partnerships: Barwon Regional Digital Plan and Great South Coast Regional Digital Plan.
- 11. The Key and Essential Worker Housing Supply Action Plan by the Victorian Planning Authority last year found almost 4,000 jobs were being filled by people living outside the Great South Coast and Barwon regions, and another 2,600 jobs were expected to be created over the next three years. The report made a range of recommendations to boost housing supply including by reducing stamp duty for over 65s, making it easier for visa holders to purchase property, creating another bus network between Geelong and Surf Coast towns, and creating a trust for any land rezoned residential to be earmarked for worker housing.
- 12. Deakin University has seen a decrease in international student enrolments in 2020 of 12% and in 2021 current estimates are a decrease of 37%. This has a further flow on effect to the local economies across BSW as the spend by international students decreases. Visits by their families has not taken place which is normally another economic contributor. A further impact is the reduced number of international students that provide capacity to the local workforce.
- 13. The *Hycel Technology Hub* in Warrnambool will be the nation's first regional hydrogen hub. It will develop and manufacture hydrogen fuel technology, with a focus on transport and heavy vehicles, storage and industry applications.

As part of the project, Deakin aims to transition its Warrnambool campus from gas to hydrogen and will convert the Warrnambool Bus Lines fleet to clean energy.

Together, the *Hycel Technology Hub* and the *Battery Technology Research and Innovation Hub 2.0* (at Deakin's Burwood campus), will accommodate 290 jobs in research, manufacturing and the energy sector and foster learning and research opportunities for school groups, university students, community and industry. Construction is expected to begin next year and will create about 78 local jobs.
